



WARRANTY

Limited Warranty

1. Unity Digital warrants that the Unity product shall be free from significant defects in materials and workmanship for a period of 5 years (Memory cards) or 2-years (USB Flash Drives, Solid State Drives, USB Card Readers) from the date of first purchase. Unity DRAM has a limited Lifetime warranty.

This warranty gives you specific rights and you may have other rights which vary under different jurisdictions.

3. You must provide a proof-of-purchase to be eligible for this limited warranty.

4. The limited warranty does not cover accidental damage, abuse or misuse, wear and tear, unauthorized repair, modification or disassembly, or use in abnormal conditions or damage caused by viruses, trojans or worms, or any other malicious programs, or consequential or incidental losses.
